# 2025-2026 Registration Policy

# Registration

The registration process is complete when the school has received:

- Completed Student Enrollment Contract in Finalsite
- Registration fees paid in Finalsite
  - o \$350 per student Kindergarten 8th grade
  - o \$250 per student Preschool/Pre-K
- · Records: Updated Certificate of Immunization Status (CIS), health forms, and birth certificates
- All tuition and fees are current

All Registration fees are non-refundable

#### **Tuition**

The School Administration under advice and consultation of the School Commission is responsible for setting up the non-refundable registration fees as well as tuition rates. Our school offers three (3) tuition payment options:

- Annual\* 1 payment (August 5th)
- Semi-Annual\* 2 equal payments (July and January 5th)
- Monthly 12 equal payments (The 5th day of every month July through June)

Tuition and incidental payments are made through Finalsite (<a href="https://guadalupe-school.fsenrollment.com/users/sign\_in">https://guadalupe-school.fsenrollment.com/users/sign\_in</a>) - enrollment fee applies. Late fees will be applied if the account is not current. Families that are experiencing financial difficulties should contact the principal immediately.

# In-Parish Tuition (optional)

Families of K-8 students register under one of two categories: in-parish or out-of-parish. To qualify for the "in-parish" discount each school year, a family must be verified by the parish office. Each enrollment year, (at contract signing) you must submit the OLG In-Parish Tuition Verification request (<a href="https://olgseattle.org/olg-in-parish-tuition-request">https://olgseattle.org/olg-in-parish-tuition-request</a>) to declare your intent. For "in-parish" status you will be asked to verify the following criteria:

- Families must be a registered household at Our Lady of Guadalupe Parish for at least 6 months prior to the start of the first day of school.
- Families must commit to the parish annual stewardship of treasure pledge its fulfillment. Minimum contribution is \$75/month. Pledge renewal campaign takes place in October each year.
- Families must participate in the Annual Catholic Appeal which begins in May.
- Families must help and participate in the spirit and social life of the parish. We encourage volunteer
  hours to include 5 hours supporting parish ministries and activities.

The school will regularly check status with the parish throughout the year, and families who do not fulfill the requirements will be billed at the out-of-parish rate.

<sup>\*</sup> Families who pay full tuition annually by July 5, 2025 will be discounted \$200 per family. Families who pay full tuition semi-annual by January 5, 2026 will be discounted \$100 per family. This discount only applies to families who pay full tuition (no tuition assistance).

### **Withdrawal Policy**

Our Lady of Guadalupe School contracts with faculty and staff and incurs financial obligations for the entire school year. In order for OLG to meet these financial obligations, when a student is enrolled, the parent/guardian assumes the obligation to pay the contract in full.

In order to be released from tuition payment obligations, the parent/guardian must:

- 1. Advise the principal in writing, and an exit interview will be scheduled.
- 2. All financial obligations must be met before a student's records will be released.
- 3. Student's records will be sent at the request of the new student's school.

Registration fees are non-refundable under any circumstances. In the event that a student withdrawals midyear, tuition paid or due will not be refunded. Tuition is due through the end of the month that a student is in attendance. For all withdrawals after the start of the school year, 50% of the remaining annual tuition balance will remain required, and can be divided up into monthly payments, or paid at once, unless otherwise determined by principal. If an enrolled student fails to start school in September, parent is released from the enrollment contract, but any tuition payments for the preceding months will be forfeited.

Extenuating circumstances regarding the withdrawal of a student will be considered on a case-by-case basis, but does not guarantee a release from contract or financial obligation.

The school reserves the right, if any tuition is past due, to remove the student(s) from the school. The school has the right to refuse re-enrollment for the following school year until financial commitments have been met.

## **Fundraising Commitments**

#### **Auction Procurement Requirements**

Each family is required to procure an auction donation item/service/sponsorship valued at a minimum of \$200 retail OR provide a \$200 cash donation (<a href="https://guadalupe-school.ejoinme.org/2026cashdonation">https://guadalupe-school.ejoinme.org/2026cashdonation</a>). All cash donations or intent to donate an item/service/sponsorship are due December 1, 2025. ### **Commitment Hours Requirements**

From June 1, 2025 through May 30, 2026, the requirements for commitment hours, or volunteer time to our school and/or parish are:

Returning families – 50 hours New families Grades K-8th – 40 hours Preschool/Pre-K – 20 hours

# **Optional Programs**

#### **Financial Aid or Tuition Assistance**

Catholic education is an investment in your child's future. All K-8 families are eligible to be **considered** for need-based tuition assistance, and must meet requirements, deadlines and criteria outlined below and in FACTS. **Tuition assistance is not guaranteed**, however limited funds are available to help make education more accessible for families who need the additional financial support.

Along with Fulcrum Foundation, OLG School may provide assistance to K-8 families who submit completed tuition assistance applications by December 31, 2024. (Applications are open Oct 1 to late December for assistance in the following school year). Limited assistance may be available for newly enrolling K-8 students who apply for tuition assistance and enroll prior to May 1. For families applying after May 1, no tuition assistance will be available. #### Requirements to maintain tuition assistance:

- Your tuition assistance application needs to be submitted on time each year by Dec 31
- Your financial account must remain in good standing
- Your family's required volunteer hours should be on track to fulfill the minimum requirements
- Your child may be asked to write a thank you message to donors

### Extended Day Care (EDC) (Grades K-8)

### **Explanation of Rates**

- Registration Fee Each family (K-8) shall pay an annual \$30 registration fee to use this program.
- Rate is \$8.50 per hour per child, minimum 1 hour charge.
- EDC is open from 7:00 AM to 6:00 PM. EDC will follow the schedule for late start if we have inclement weather.
- Invoices will be created by the end of the month reflecting the prior month's balance.
- Late Pick-up A fee of \$1 per one (1) minute after 6:00 PM will be added to your monthly statement.
- Failure to pay these fees will result in your child being denied care until payment is made.

# Early Learning Center (ELC) Aftercare (Preschool/Pre-K)

## **Explanation of Rates**

- \$200 per month per child for after school care.
- After care is open 3:00-6:00 PM. Other schedule options are at the discretion of the ELC Director (<u>imcclelland@guadalupe-school.org</u>).
- Invoices will be created by the end of the month reflecting the prior month's balance.
